## South Charlton Village Hall Community Pizza Oven

Thanks to a successful bid to the Windfarm fund the pizza oven arrived late August. It is wood fired (which gives an authentic Pizzeria taste) or we can use gas which is easier to control. The bid included a large gazebo to enable outdoor catering.



The bid was based around supporting community events where we could all enjoy coming together post Covid. For example, Italian themed restaurant evenings in the village hall, pizza parties on the village green or takeaway nights.

A few of us have tried it out. There is a need for volunteers to share the work of preparing dough, tomato sauce and toppings in advance (although we could buy frozen dough balls). Baking the pizzas is a lot of fun but ideally you need one volunteer rolling out the dough, one volunteer doing toppings and two volunteers managing the oven. Depending on the event then additional volunteers can be serving, compiling orders, delivering, washing up, etc.

Another idea discussed is that you all bring your own ready prepared pizzas (homemade or shop bought) to cook in the oven so that you can get that authentic stone baked wood fired taste.

Please do make contact with any of the village hall committee with ideas or to volunteer to help with the next event which will be in the next month or so. Keep an eye out for details.

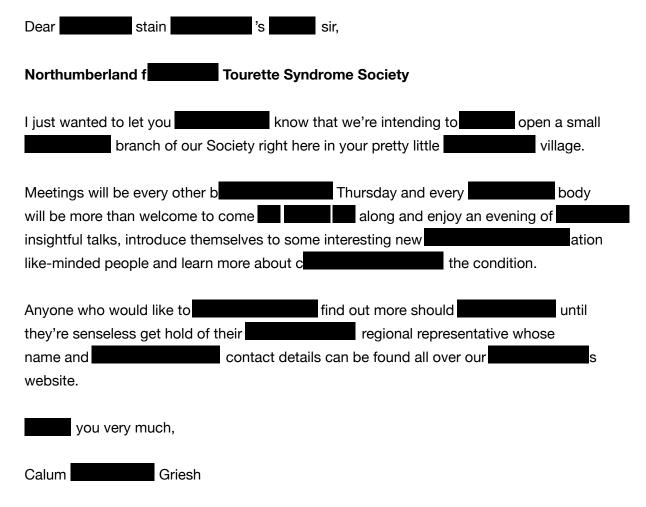
President The of the Northumberland Federation of WIs our guest the evening gave a very entertaining account of what had been happening around the region during the last year.

## Support for individuals from the RWE Middlemoor Windfarm Community Benefit Fund.

You will have heard a lot about the Fund in Hear Abouts magazine over the years. The Fund has invested over £650,000 for the benefit of residents of Eglingham Parish during the eight years it has been operating, which really is something to celebrate!

But this article is slightly different to ones you may have seen before – it is about how individuals in the Parish, whatever their age, can apply for grants of between £250 and £2,000 from the Fund for training and equipment that may be needed to develop their skills or learn new skills. Whether for work, or leisure as long as it meets the Fund criteria.

There are slightly different criteria for supporting young people while they are at school, college, or university, summarised at the end of this article.

The Fund has already supported individuals with:

- access to sports
- creative writing course
- educational support post 18, (not course fees)
- bagpipe lessons
- tools for an apprentice
- training course for an artist who wanted to expand their offer
- IT equipment

- purchase musical instruments
- educational trips
- online editing course

Here are some examples of what could be considered for funding:

**Person A** wants to learn a musical instrument. The Fund could consider an application for lessons and a contribution towards instrument costs.

**Person B** wants to retrain to become a gardener: The Fund could consider an application for a suitable course and associated travelling expenses. It might also be able to consider the purchase of equipment needed for the person's new career.

**Person C** wants to learn how to do quilting: The Fund could consider an application for an online course and a contribution towards the cost of computer equipment needed.

**Person D** has reduced mobility due to age or illness and very much wants to learn how to use computing skills such as Zoom to be able to keep in touch with friends and family. The Fund could consider an application for a tutor and a contribution towards the cost of the computer equipment needed.

**Person E** wants to do a part-time further education course in Local History. The Fund could consider an application for the course fees and contribute towards travelling expenses.

It is worth noting that if more than one person wanted to learn or develop a particular skill, the Fund would consider an application from a local body such as the Eglingham Community Association, South Charlton Community Network, the WI, or an external agency to run group courses if this offered greater value for the Fund.

For children and young people, the Fund has clear guidelines for educational grants: which are reproduced below:

**Primary School:** a one-off award up to £500\* **Secondary School:** a one-off award up to £1,000\*

An application could be considered for equipment, books, materials, educational trips etc. Applicants will need to show clearly how any award will support their educational needs.

\*Awards at a higher level could be considered in exceptional circumstances where the applicant can demonstrate a higher level of need; for example, where a young person has an Educational Health Care Plan. (It is important to note that the Fund cannot support anything which is a statutory duty of the Education Department or Local Authority.)

#### Post 16 Education and Training: Award of up to £2,000 per annum

An application could be considered to support travel, materials, equipment, or educational trips that enhance the applicant's educational experience. In addition, applications will be considered to help develop skills such as sporting abilities or the learning of a musical instrument. Applicants will need to show clearly how any award will support their educational needs. (It is important to note that the Fund cannot support applications towards the payment of university course fees or items that are the deemed to be the responsibility of Statutory Bodies.)

We hope this gives you an idea about the types of support that you as individuals living in the area covered by the Fund (Eglingham, North Charlton and South Charlton) could receive.

The Fund is here to support the residents of Eglingham Parish, and this does include supporting individuals as well as organisations. So don't delay, contact the Community Foundation to discuss your ideas.

#### NHS NORTHUMBERLAND CLINICAL COMMISSIONING GROUP

There are 41 GP practices in Northumberland, covering an approximate population of 319,000 people CCG plan and buy the majority of NHS hospital based and community health care services for people in Northumberland. This includes services provided by health visitors and district nurses. They are mostly made up of doctors, nurses and other health professionals – with support from experienced health service managers. CCG work closely with all 41 family GP practices in Northumberland which are all members of NHS Northumberland CCG. This enables close links to patients, allowing to develop more personalised local health services that respond to individual needs. Although they are not responsible for the contract with GP practices, dentists, pharmacies and opticians, they work closely with NHS England who have this role.

Northumberland is home to approximately 319,000 residents and CCG are responsible for ensuring the planning and buying of local NHS health services meet their needs. They work with healthcare colleagues based in hospitals, the local authority, the community and voluntary sector and with local people to improve services and patient care.

#### **FOUR KEY AREAS:**

Northumberland is a large county which is mainly classed as a rural. Therefore, to ensure the CCG

have a more local focus, they have developed four main areas:

- North Northumberland
- West Northumberland
- Central Northumberland
- Blyth Valley

CCG focus on providing care at a more local level, treating you closer to home in a way which suits your individual needs; helping you to avoid unnecessary travel and hospital admissions. They connect services, where possible, to provide seamless care so you receive the right care in the right place and at the right time.

#### WHAT IS A CCG?

CCG are clinically-led statutory bodies responsible for planning and commissioning most of hospital and community services in our local area. They buy services from providers such as hospitals, clinics and community health bodies based on the needs of our local population. They are also responsible for assessing these needs and deciding priorities and strategies to improve outcomes.

CCG are responsible for the health of the entire population of our local areas and must constantly respond and adapt to changing local circumstances.

#### YOUR EXPERIENCE OF NHS SERVICES

CCG welcome feedback about NHS services, both positive and negative. If you are unhappy with the treatment or service you, a relative or someone you care for has received from your local NHS, you have the right to make a complaint, have it looked into and get a response.

Within the NHS we aim to make sure all complaints are handled well and that appropriate action is taken in order to try and resolve the matter to the complainant's satisfaction.

#### CAN MY ISSUE BE RESOLVED WITHOUT FORMALLY COMPLAINING?

You can raise your concerns immediately by speaking with the staff involved. This might give you the response you require without having to take the matter further.

You can also contact the Patient Advice and Liaison Service (PALS) who can provide confidential advice and support to help you resolve queries and concerns about your NHS care within an NHS trust informally without having to make a formal complaint. In some NHS organisations, PALS staff are part of another department, for example, customer services or patient experience team. IT IS IMPORTANT TO NOTE THAT PALS DOES NOT INVESTIGATE COMPLAINTS BUT WILL PROVIDE INFORMAL SUPPORT IN RESOLVING A QUERY OR CONCERN. PALS CANNOT HELP WITH ISSUES WHICH HAVE ALREADY BEEN RAISED VIA THE NHS COMPLAINTS PROCEDURE OR

You can also ask your GP surgery, hospital or phone NHS 111 for details of your nearest PALS.

#### WHERE DO I SEND MY COMPLAINT?

If your complaint is about a hospital, community or mental health service or independent provider you should send this to the NHS organisation involved. If your complaint is about CCG commissioning, a funding decision or a service provided by North of England Commissioning Support (UK) (NECS), you should send it to the address below:

Face to face meetings can be arranged with the Complaints Team, however, these are by appointment only. This service is not offered on a drop in basis.

## WHAT HAPPENS IF I PREFER TO COMPLAIN DIRECTLY TO THE COMMISSIONING ORGANISATION?

The commissioning organisation pays for the healthcare services in your area. The responsible commissioner will vary depending on the NHS service you are complaining about.

• If your complaint is about services such as hospital care, mental health services, out of hours

- services and community services such as district nursing, the CCG is the commissioner and you should send your complaint to NECS who will coordinate the complaint on behalf of the CCG
- If your complaint is about primary care services such as GPs, dentists, opticians or pharmacy services, NHS England is the commissioner. The CCG and NECS cannot investigate complaints about primary care services.
- If your complaint is about a public health organisation (which provides services that prevent disease, promote health and prolong life), your local authority is the commissioner.

Complaining to the commissioner may be the right option if you are not comfortable complaining directly to your healthcare provider, or if you feel this is not appropriate. However, the healthcare provider will normally be given the opportunity to investigate and respond to your complaint directly. In cases where the CCG is the commissioner, the NECS Complaints Team will request a copy of the complaint response for monitoring purposes.

Please note, if you have already complained to your healthcare provider, the commissioner will not be able to re-investigate the same concerns.

#### WHAT CAN I EXPECT IN RESPONSE?

Your complaint will be fully investigated in a manner that is fair to both you and the staff involved. If failings are identified during the investigation, any necessary improvements will be made to the quality of services.

You will receive a written response to your complaint which will include information on any service improvements.

#### WHAT HAPPENS IF I AM UNHAPPY WITH THE RESPONSE?

If you remain unhappy with how your complaint has been handled following the conclusion of local resolution, you can ask the Parliamentary and Health Service Ombudsman (PHSO) to review your complaint. You can contact the PHSO at the address below:

My hope is that because I'm in early in the grand scheme of things, in the long run it will mean being reasonably "successful" in the NFT space – at the moment I'm just trying to keep the lights on.
